Program Description

Schooling & Graduation

- Schooling: 2(two) years
- Intake: each September(autumn semester)
- ➤ 1st academic year: full time courses learning, 34 compulsory credits and 10 elective credits must be acquired.
- ➤ 2nd academic year: project practices, internships, thesis writing and defense.
- > Graduation: those who complete the required credits and internship/project practices, finish the thesis and pass the defense will be granted a master degree.


